IN our last we congratulated those now at school on their obtaining possession of an excellent cricket ground for their own exclusive use. We are now in a position to congratulate "old boys" on the inauguration of a Scotch Collegians' Society. The objects of the association are fully set forth in its rules, which appear in another part of this issue, and to which we refer our readers. The matter has been taken up with enthusiasm, and the committee elected is such as affords ample guarantee that the affairs of the society will be managed with energy and discretion. The annual and quarterly meetings which it is proposed to hold will enable old school friends to meet again and keep up their acquaintance with each other. Apart from the mere pleasure of meeting school-mates and living over again in thought the days that are bygone, such gatherings will afford a much-needed respite from the harassing cares of adult

life. Especially in this age of intensely keen competition and consequent hard toil is it incumbent on workers now and again to relax the strain which presses so heavily on all, and forgetting business difficulties and professional anxieties, to recall the careless, happy days of boyhood, even although its reminiscences should occasionally serve "*renovare dolorem*."

It is true that these pleasant glimpses of youth are soon lost sight of amid the jostling and stern realities of life. Still it were good for all occasionally to have an opportunity of casting a retrospective glance, and of comparing the fulfilment with the promise of earlier days.

THOUGH it may be considered unquestionable that there exists in different individuals original and hereditary variations of character and capacity, there can be no doubt that training and education are by far the most important agents in inducing those qualities which distinguish one man from another. The inborn grain which unalterably fixes the nature of the raw material provides for that diversity, without which the aspect of the universe would be unbearably monotonous, and intercourse with our fellows meaningless and uninteresting. On the other hand, patient labour and cultivation have the power to turn every disposition to good account, and shape it for filling worthily its allotted place in the scheme of things.

Upon parents and teachers, doubtless, falls the main responsibility of carrying, to the extent of their ability, this object into effect. At the same time, those under their care are by no means exempt from the obligation of self-culture. It is universally agreed that such an obligation rests upon all men in general; and, as it is impossible to assign any particular period when its operation is to commence, we may safely assert that as soon as a child's powers of reflection are sufficiently developed to enable him to understand clearly the difference between good and evil, he is morally bound to strive after the one and to avoid the other. And all education, rightly considered, means nothing else.

There is no way in which young folks can more effectively supplement the efforts of their instructors than by the assiduous cultivation of good habits. Habits of some kind we must all have; our life consists of them. Every action we perform is the beginning of a habit; it is as the spinning

of a thread, whose thickness and strength is increased with every repetition of the action, and whose power to draw us along the same course becomes by insensible degrees irresistible. Carlyle says: "Habit is the deepest law of human nature. It is our supreme strength, if also, in certain circumstances, our miserablest weakness. Let me go once, scanning my way with any earnestness of outlook, and successfully arriving, my footsteps are an invitation to me a second time to go by the same way; it is easier than any other way. Habit is our primal fundamental law—habit and imitation—there is nothing more perennial in us than these two. They are the source of all working and all apprenticeship, of all practice, and all learning in this world."

One valuable habit which we would earnestly advise our readers to form for themselves is that of reverence. The sneer and the scoff are but too prevalent in these days, when every reader of a newspaper article, or a magazine review, thinks he has arrived at the utmost limits of science and wisdom. This sort of smartness has a very dangerous temptation for young people, and nothing is more painful and hideous than the peculiar air of knowingness (sure sign of know-nothingness) which many of them assume. Conceit of this kind, if persisted in, rapidly deteriorates the best natural disposition, and blunts the most acute moral sense; the final result being a disbelief in the existence of the good, pure, and honourable, and the assigning of motives of self-interest to the noblest actions. Nothing can be more fatal to a lad than to think it clever to regard everything above him in a flippant and familiar manner. If a want of reverence were nothing worse, enough to

condemn it would be the fact that it is in the lowest degree vulgar.

If we have once accustomed ourselves to respect what is superior to us, we shall have no difficulty in acquiring the closely-related virtue of obedience. Subordination is the bond which holds together every association of human beings. Without it, the wildest anarchy, impossible to conceive, would reign supreme. The State, the family, the school all exist by virtue of the principle:—Submission to just authority. So well is this understood that, if not yielded willingly, the necessary obedience is enforced by the severest means when requisite. Thus, he who foolishly resists fair and reasonable commands, not only suffers the punishment of his contumacy, but is ultimately compelled to give way without receiving any credit for his compliance. Whereas, nothing is more graceful than prompt and cheerful obedience which wins for us the favour of our superiors, and renders us fit to command in our own turn.

Among the qualifications which assist a man in the attainment of that success in life which we all strive after, not the least effective are order and regularity. The work which is carried out on a plan deliberately and carefully premeditated, is always better performed than that which is alternately neglected and precipitately hurried; and the life which is lived steadily and evenly is healthier, more useful, and more comfortable than that in which excess in one direction is followed by excess in another. In the same way as an army or a school would fall into inextricable confusion, unless the different elements composing either were duly and systematically adjusted to fit in and work harmoniously with the others, so the various faculties, desires, needs,

and duties of each individual should be arranged so as not to interfere with one another. One of the worst forms of irregularity is procrastination, and most of the worry and anxiety suffered by those who have to perform a certain task in a certain time is due to this cause alone; whereas a methodical and orderly disposition of time and resources makes labour pleasant and doubles its value.

Closely connected with, and, indeed, naturally arising from, habits of regularity, are those of neatness and punctuality. What is done at its proper hour, and with calmness, can well be done with care and exactitude. The good impression produced by neatness in appearance, in speech, in writing, is of immense advantage to a youth entering life. The habit of punctuality, too, is of the highest importance in these times, when the clock is the sternest ruler of our daily lives; its warning hand cannot be disregarded with impunity. The ominous exclamation, "Late again to-day!" is the death-knell of advancement in the office as well as in the school.

Binding together and confirming all the other habits, and a necessary agent in their acquirement, is the grand habit of industry. The chief labour of youth is that of preparation and equipment. When the battle is nigh, it is too late then to think about going through a course of drill and learning the use of our weapons, as many have discovered to their cost. Let our lads, therefore, resolve to take advantage of the time before them, and endeavour, by earnest and determined application, to sharpen, exercise, and direct those faculties with which, at no distant date, they will have to face the world and its difficulties.

EXAMINATION RESULTS.

Parents and guardians are reminded that all boys below Class V. receive on Fridays printed slips, on which are entered the results of the examinations held during the week. These returns are afterwards to be entered on the result-cards, which are to

be kept at home until called in for inspection. The weekly returns give the number of marks obtained out of a total of fifty, and the average of the class. In the "Judgment" column, P stands for "pass," and signifies that the result is considered satisfactory; N stands for "not pass," and implies that the result is not considered satisfactory. In arriving at a decision, the difficulty of the examination and the capacity of the boy are in every instance taken into account.

Notes and Comments.

THE fourth and last term of this year commenced on Tuesday, the 7th inst.

ELSEWHERE we insert a full report of meetings held to initiate an Old Scotch Collegians' Society. The association has been successfully started, an influential committee has been elected to manage its affairs, rules have been adopted, and it is proposed to hold the first annual reunion early in November.

WE publish in this issue a complete list of students who entered the College during the twenty years extending from 1857 to 1876 inclusive. The list will, we hope, be useful to the committee of the Old Collegians' Society. The roll is a long one, and cannot be expected to be perfectly accurate. It will be republished, and meantime we invite notification of errors.

So far as is at present ascertained, of the students who entered up to end of 1876 about 380 have passed the Matriculation Examination, and about seventy degrees have been taken.

MONDAY, the 3rd of November, is the last day fixed for receiving the names of candidates for the December Matriculation Examination.

DR. J. W. PHILLIPS has been elected one of the honorary physicians to the Melbourne Benevolent Asylum. Dr. Phillips, who lately returned from Europe, is now practising his profession in West Melbourne.

DR. THOMAS HASTIE, who lately returned from Scotland, where he was prosecuting his medical studies, has received an appointment in the Sydney Royal Infirmary.

DR. HENRY RAY, who lately graduated at the University of Glasgow, has been appointed one of the resident medical officers at the Bendigo Hospital.

DR. ANGUS MUNRO, formerly one of the medical officers at the Melbourne Hospital, has lately passed at Edinburgh as L.R.C.S. and L.R.C.P.

MR. A. F. MORRISON, M.A., LL.B., has been admitted as a barrister at the Supreme Court of Victoria. Mr. Morrison, who is the eldest son of the Principal of the College, sailed for India by the last mail steamer, *en route* for London, where he purposes prosecuting his legal studies, with the view of being called to the English bar.

MR. G. M. BARTHOLD, lately with Messrs. McGregor, Ramsay and Brahe, of this city, is now practising as a solicitor at Murchison.

MR. W. H. LEONARD, of Messrs. McKean and Leonard, took an active part at the last meeting of representatives of the school boards of advice. Mr. Leonard is a member of the Carlton board.

MR. JAMES McHUTCHISON has successfully passed the examinations prescribed by the Board of Examiners for admission to practise as a surveyor.

ELSEWHERE we give particulars of some of the results of the Melbourne Medical Sports, and of those of the Sydney Amateur Athletic Club. It will be seen that old collegians have more than maintained their reputation.

SOME time since the Principal, through Messrs. Alston and Brown, forwarded to England an order for the manufacture of school badges. These are being made of silk, the device being woven in, and it is expected that they will arrive in the course of a few weeks.

WE have several times complained that boys will not volunteer contributions. As a specimen of original composition, we insert the following which lately appeared on the sports notice board:—"NOTICE.—Mr. J. G. The Australian Health Society.

IN order to encourage the study of the laws of health, the Council of the Health Society propose to offer prizes of the total value of £20, to be competed for in June next by pupils from the principal schools in Melbourne and suburbs. The questions for the examination will be based upon the information to be obtained from the following works:—"Foster's Primer of Physiology," and "Hardwicke's Health Primer." There will be eight prizes in all, varying in value from £5 to £1. Physiology has for several years been taught at the Scotch College, and "Foster's Primer" is at present in use in the second and third classes. In the higher classes the text-books in Collins' Series have been used. We trust that the efforts of the Society to give an impetus to this study will be successful; and with this view we would recommend that, in addition to the prizes, certificates should be given to all candidates who attain a certain fixed standard of excellence, as tested by the examination papers. Only a few boys, at most, can hope to obtain a prize, whereas almost all might expect to obtain a certificate. The stimulus to work would thus operate through a whole class, and would not be confined to the few. There should also, we think, be some limit to the age of the candidates. The Board of Examiners for 1880 includes the names of Dr. Jamieson, of Collins-street, and Lloyd Tayler, Esq., architect.

Athletic Sports Meetings.

THE University Medical School sports were held on the 16th August on the East Melbourne Cricket Ground. The weather was rather unfavourable, and this, to some extent, prevented a large attendance of the public.

We are glad to observe that the first place in almost all the important events was won by Old Scotch Collegians. The Champion Cup, a handsome trophy of the value of ten guineas, was won by J. P. Montgomery, with twenty-five points. We congratulate Mr. Montgomery and the other gentlemen whose names appear on the list, on their achievements. We are also glad to observe that an old Collegian distinguished himself at the late sports of the Sydney Amateur Athletic Club. This meeting was held on the 27th September, and the "Metcalfe" gold medal was won by J. F. Pike, after what the *Sydney Morning Herald* calls "a fine contest." We observe that at Sydney the high jump and vaulting were won respectively by 5ft. and 8ft. 9in., considerably below the results obtained at the Medical Sports in Melbourne.

Athletic Sports.

SPORTS MEETING, 1879.

THE following events will be open to competitors should a sufficient number of boys enter. In all the events points will be given, five for the first place, three for the second, and two for the third. The winner of the highest number of points in the open events (30 excepted) will be declared champion athlete of the College; and the winners of the highest number of points in the events under 16, 14, and 12 years respectively, will be declared the champion athletes for these years. In under age events only one year's handicap will be allowed. Entries must be made on or before 1st November. All entries must be in writing, and must contain the name in full, and the number and name of the event. In under age events, the age last birthday, together with the day and year of birth, must also be given.

In every case ages will date from 1st November. No vaulting will be allowed in the Hurdle Race. Event 17 will be competed for early in October; events 2, 3, 6, 7, 12, 13, 22 and 23, early in November; and events 18 and 19, at the end of November. The remaining events will come off on the day fixed for the sports meeting in December.

Rowing.

SINCE the publication of our last number considerable interest has been manifested in the selection of our second crew. To choose the right man for the right place is never an easy task, and to put four men in their right places is certainly not a whit easier. Those who have not

experienced the pleasure of trying to arrange a crew to the best advantage can scarcely imagine the various difficulties that arise, and that have to be overcome. However, in this case we may say, with a reasonable amount of confidence, that we have got together the best crew possible from the material at our disposal. Whether they are good enough to win the race remains to be seen. Let us hope that the result may be satisfactory. But whether victors or vanquished, we have done all that lay in our power to achieve success, and we shall accordingly bear either result with equanimity.

The crew as now arranged are—Austin, E.; Neave, F. J.; Cumming, W.; and Adams, J. The stroke oar is entrusted to Adams. A great responsibility rests upon him. If we win, then he will get the praise; while, on the other hand, he must remember that the stroke is nearly always blamed for the losing of a race. With this thought to stimulate him, and with the remembrance of Elliott's rowing to encourage him, what doubt can we have that Adams will show that he, at any rate, is the right man in the right place? The remaining members of the crew diminish gradually in size from huge and mighty Cumming to slim and elegant Neave, and thence to our bow, the long-enduring Austin. The two last named have already displayed their prowess as oarsmen in some sculling races which took place about a month since. The first two heats rowed in these sculling contests were won by Brodie and Neave respectively, against the brothers Austin. But in neither event was the loser beaten on his merits, inasmuch as, on each occasion, the stretcher of the luckless hero gave way within the first hundred yards. The final heat was more keenly contested, Brodie winning by two or three lengths, but the race being rowed again on a subsequent evening, Neave having Brodie's boat, and *vice versa*, the former result was reversed, Neave winning by about the same distance as Brodie had done. We are therefore at present left in doubt as to which is the better sculler. Perhaps when the second crews' race is over another match may be arranged. Adams and Cumming have never before this engaged in a rowing contest, and must therefore gain their first laurels in the forthcoming race. Before many days have passed the result will be known, as the first heat is arranged for Monday, 18th October, between our crew and the Wesley College, at four o'clock. The second heat is to take place the same evening, at half-past four, between the Melbourne and Geelong Grammar Schools. The final heat will be rowed on Tuesday, 14th October, at four o'clock, but it is at present somewhat premature to conjecture who will be the competitors. We have however good

hopes that our crew will be in it, for they are rowing well together and improving daily under Wallace's able guidance. Assiduous in their practice, and attentive to their coach, they deserve success, and we trust they may achieve what they deserve. The training has produced a marked effect in the appearance of some of them, and even the stalwart Cumming is beginning to show signs of its power. His face is not now so sad as it was when he first realised the fact that he weighed nearly two hundred pounds.

A meeting of the public schools' delegates was held on Saturday, 27th September, for the purpose of arranging the details in connection with the race. It was resolved to ask Professor Irving to act as starter and umpire and Mr. A. Nichols as judge. A proposition brought forward to the effect that in the second crews' race the coxswain must not be the one who steered in the first crews' race, was, after an animated discussion, remitted for future consideration, so that in this race, as heretofore, we trust to have our faithful Freddy Edwards to guide our crew to a well-earned victory.

The Albert Park Regatta is likely to be productive of some excitement among the various schools, inasmuch as the programme includes a race for the Public Schools Cup, open to any school in Victoria without restriction. Our crew, who brought the Sumner Cup in triumph from Geelong, are thinking of entering for the contest, and, should they do so, they will meet again their former antagonists, as the Geelong Grammar School crew are anxious to regain their lost prestige. The date fixed for the regatta is the 29th November, so that plenty of time is allowed for proper preparation. Most assuredly it will add materially to the interest of the regatta if two such crews fight their battle over again, especially if, as an additional attraction, other schools should send representatives. Both the Hawthorn Grammar School and the Kew High School, as well as the other Public Schools, have devoted much care to rowing, and could prove themselves formidable opponents.

Football.

THE football season is over, and we are now in a position to review the results for the current year. From these it will be seen that our representatives have again been very successful, and that, as in the two previous years, they sustained no defeat in any School match. Altogether eight matches were played, of which five were won, two were drawn, and one was lost. Of goals, twenty were obtained, and eight were kicked against us. Of these twenty goals P. T. Brodie

kicked no fewer than seven; Armstrong, A. G. Brodie, Clendinnen and Morrison, two each; and Aitken, Balcombe, Montgomery, Speary, and Wynne, one each. We insert an abstract of the results for the season, remarks upon the players, and a report of the matches which have taken place since our last issue.

Adams, J.—Plays splendidly either forward or back; is a most determined player; kicks and dodges well.

Aitken, D.—One of the best followers in the colony; as for marking cannot be excelled; splendid runner and magnificent kick.

Armstrong, T.—Rather light; kicks and marks well.

Austin, H.—A good man on the wing; runs well; always goes for the ball, and generally gets his kick.

Balcombe, H.—A very useful forward man on the wing; keeps his place well, and always goes for the ball.

Brodie, A. G.—Plays very well centre forward; marks well and is a grand kick.

Brodie, P. T.—The goal-sneak of the team; splendid mark, and good kick either foot.

Clendinnen, F. J. (Capt.)—First-class back player, good dodger, mark and kick. Uses great judgment in placing his field.

Cumming, W.—A medium player, works hard, but not effectively.

Ellerman, A.—An excellent follower; never tires; all there for the ball, and generally gets his kick.

Elliott, H. C.—Good steady player, follows well, is a very good mark, and is a fair kick.

Hornby, A.—Plays in centre; can play well when he likes, but unfortunately seldom does like.

Juckles, T.—Plays a dashing game as centre half back; marks splendidly, and kicks well either foot.

Macpherson, J.—Capital player on right wing; kicks, marks, and runs with ball well.

McNicol, H.—Medium follower; marks well; kicks fairly; is very good at playing little marks.

Montgomery, H. G.—Splendid all-round player, and good kick; plays hard from start to finish of a game.

Morrison, H.—Left early in the season. Fair goal-sneak; worth twice his weight; sticks well to his man.

Neave, F. J.—Heavy forward player; good mark and kick.

Robertson, F.—Very fleet of foot; good kick, and marks well; is rather fond of holding the ball.

Rutherford, J.—An excellent all-round player; light, but full of vigour; also, good change follower.

Taylor, I.—One of the most reliable players in the team; as a back, not showy, but effective, seldom loses the opportunity of a good kick.

Thomas, R.—A very good player on wing; improved greatly since last season.

Whan, W.—Fine player on the wing, always gets his kick.

SCOTCH COLLEGE *v.* CHURCH OF ENGLAND GRAMMAR SCHOOL.

THE second match between these schools took place on the 14th September, on the St. Kilda Ground. The first match was won by the Scotch College by six goals to one. Since then the School team had been strengthened by the addition of some former players, such as Coldham, Rogers, and Stephen, and their supporters were very confident that they would be more than good enough for their opponents. Clendinnen, the Scotch captain having won the toss, elected to kick up the hill, while his team was fresh. The ball was sent off by Hume, the captain of the school. During the first half, the game was very even, each side securing three behinds, though the Scotch had a couple of easy shows to score, especially Austin, who had a shot within ten yards, but only kicked it behind. Neave also made a very good running kick, landing the ball in the goal-keeper's hands. Marshall likewise had an easy shot for the School, but failed. After half-time, the College who had the advantage of playing down hill, made it very warm for the school backs, principally by the agency of Aitken, Ellerman, and Robertson. After several ineffectual attempts to score, Brodie, jun., secured a mark and sent the ball fairly through, thus securing for the College the only goal obtained during the match. Hume having kicked off, the School team now rallied up and took the ball by several rushes, headed by James and Rogers, up to the College goal, but Clendinnen and Taylor sent it back to the School quarters, where Neave made a splendid mark, but not

allowing for the wind, only scored another behind. Hammond kicked off, sending the ball to Rogers, who again sent it up to the College goal, where it was kicked through, but as this was after the ball had been behind it was given no goal. For some time after this the play again became very even. When time was called the College team were thus victors by one goal and eleven behinds. to six behinds. The play was considerably interfered with by the spectators, who in their eagerness would not keep off the ground.

For the College Aitken and Ellerman played magnificently, and Adams, Elliott, Montgomery, and Robertson did good service. For the school, Hammond, Hume, James, and Rogers played very well.

SCOTCH COLLEGE v. WESLEY COLLEGE.

The return match between these teams was played on the 27th August, on the St. Kilda Ground. It resulted in a draw, each side securing two goals. The Wesley having won the toss, kicked up hill. Clendinnen having kicked off, the ball was immediately rushed to the Wesley goal, where it remained for some time, until after several vain attempts the Wesley followers got the ball away, and took it up to the Scotch goal, and scored first behind. Clendinnen kicked off, and the ball was quickly taken forward by Aitken and Ellerman, but the Wesley backs fought sternly, and the play was once more in the centre. By the repeated efforts of the Scotch team, amongst whom Aitken was most conspicuous, the Wesley goal was once more placed in siege, and several behinds were kicked in quick succession, one of them being an extremely good shot at a 'very difficult angle by Brodie (jun.) The Wesley now rallied up, and Parnell and Munro got the ball away to the Scotch goal, but Adams made a nice run and brought the ball well into the centre, where it remained for some time. The game was at this time very fast. After the ball had been taken away from the centre by Aitken and Montgomery, it remained in dangerous proximity to the Wesley goal, until Brodie (jun.) getting the ball out of a scrimmage, ran forward and landed it between the posts. First goal for the Scotch, who, likewise, had five behinds to their opponents two. From this until half-time the game was all in favour of the Scotch, who scored five behinds to their opponents' one. When the ball was thrown up the Wesley rushed it forward to the Scotch goal, where it remained for some time, notwithstanding the repeated efforts of Adams, Taylor, and Clendinnen, who tried hard to force it back; but at last Aitken got the ball and took it to the Wesley goal, where another behind was scored. The ball being kicked off, Parnell by a good kick

sent the ball well forward, and once more the Scotch goal was attacked. The play of the Scotch, with the exception of Aitken, was not up to the mark; they tried to run too much instead of taking their kicks, and likewise tried to give little marks, a thing in which they were very deficient; whereas the Wesley took and gave little marks with great proficiency. The play was now near the Scotch goal, and Turnbull, who had a free kick, made a magnificent kick and scored a goal for the Wesley. Brodie (sen.) kicked off, and the Scotch woke up a little, and by the play of Adams, Aitken, and Balcombe, the ball was forced up to the Wesley goal, where Brodie (jun.) scored another goal for the Scotch. Once more the Wesley by another good rush got the ball in front of the Scotch goal, and Stewart scored another goal, thus making the game even. Now the Scotch rallied up, and until time was called had all their own way. Just as time was called Clendinnen kicked a goal but it was not allowed. For the Scotch, Aitken played a brilliant game, and was ably seconded by Adams, Brodie (jun.) Clendinnen, Ellerman and Jukes; for the Wesley, Munro, Parnell, Tatchell and Turnbull distinguished themselves.

SCOTCH COLLEGE (25) v. UNIVERSITY.

This match was played on the 19th August, on the Princes Oval, and resulted in an easy victory for the College, by five goals to one.

Clendinnen having won the toss, play was started by Murray kicking off for the University. The ball was quickly rushed up by the College to their opponents' goal, and a few minutes after commencing, Aitken got hold of it and put it neatly through the posts. Goal No. 1 for the College. Murray again sent the ball off, but the College followers were not to be denied, for Montgomery with one of his long punts, secured goal No. 2 for the College. Murray having again kicked off, the ball was taken down to the College goal, but Clendinnen was about, and sent the ball forward, and it was gradually taken up to the University goal in spite of Simson and Oakley. Bennie now gave Brodie (sen.) a mark in front of the University goal, and he by a nice long kick sent the ball through and scored No. 3 goal for the College amidst great applause. After the ball had been kicked off the play was for some time about the centre; Springthorpe and Simson for the University, and Thomas and Macpherson for the College doing good work. The ball, however, was gradually worked up to the University goal, although Downes and Lamrock were striving to defend it, until Palcombe, who was working hard, getting hold of the ball, ran it up and kicked goal No. 4. After this, the game was pretty even and the

University secured one goal through the agency of Morton. After half-time the College settled down to their work and made it very warm for the University backs, Lamrock sent the ball forward only to be returned by Macpherson, and Wynne getting the ball secured goal No. 5 for the College. From this period until time was called, the play was very even. Aitken, Balcombe, Macpherson and Montgomery played well for the College; as did Champion, Downes, McGuigan, Oakley and Simson for the University.

Mr. O'Neil of the Hotham Football Club gave general satisfaction as central umpire.

The Society of Old Scotch Collegians.

FOR some time past there has been a strong feeling amongst old scholars that it was desirable to devise some means of associating together those who had been educated at the College. A meeting to consider the best method of attaining this object was lately called by advertisement, signed by the Hon. Robert Ramsay, M.L.A. Previous to the meeting being held, the following circular was sent by Mr. Knox, of the Bank of Victoria, to the old boys whose address was at the time obtainable:—

TO THE OLD BOYS OF THE SCOTCH COLLEGE,
MELBOURNE.

At the preliminary meeting on the 9th inst., I hope to propose the following resolutions:—

1st. "That the meeting at once resolve itself into a society to be called 'The Old Scotch Collegians.'"

2nd. "That the chief object of the society be to hold annually a social gathering of its members, and foster the interests of old collegians."

3rd. "That all who have been scholars of the Scotch College shall be considered members of the society, provided they have attained the age of twenty-one years."

4th. "That at each annual social meeting, a president, a committee of six, and an honorary secretary be appointed."

(a) The duties of the committee be to make all necessary arrangements for the next ensuing annual social meeting, sale of tickets, &c., and transact such other business for the society as may arise throughout their year of office.

(b) The duties of the honorary secretary be to keep the rolls and records of the proceedings of the society—to prepare and read at the annual meeting a short paper on subjects of especial interest to old collegians.

And in the event of the foregoing being agreed to, 5th. "That this meeting elect a provisional committee."

(a) To make arrangements for the first annual gathering. (b) To prepare a set of rules for the guidance of the society, to be framed in the spirit of the above resolutions, and print same for distribution.

I have taken the liberty of placing the above before you in this form in order that the proposals may receive full consideration, and such modifications as their hurried construction will doubtless demand.

I am of opinion that if the suggestions are generally approved and supported the effect will be to ensure continuity to the present movement, a greater interest in it, and a degree of cordial fellowship and success which could not be attained by simply leaving our proposed annual dinner to the chance zeal and energy of a necessarily varying few.

The movement would to my mind be thus placed upon a systematic basis, and its continued existence and prosperity firmly established. Further, I am satisfied the perusal of the records of such a society, and a glance through the good old names of schoolboy days would in the long years to come be the source of much gratification and pleasure, and of the happiest remembrances to many

AN OLD COLLEGIAN.

Collins-street, 1st September, 1879.

The meeting was held at Gunsler's Café on the 9th September, at which it was resolved, on the motion of Mr. W. Knox, to form a society to be called "The Old Scotch Collegians." A committee consisting of the Hon. Robert Ramsay, Messrs. J. F. Turnbull, D. Wilkie, A. E. Clarke, and Wm. Knox, were appointed to draw up rules. These were submitted to a subsequent meeting, held on the 16th instant, and were then adopted. A committee of management was also

appointed, consisting of:—President—Hon. Robt. Ramsay, M.L.A.; Vice-Presidents—A. E. Clarke, D. Wilkie; Hon. Secretary—W. Knox; Hon. Treasurer—J. F. Turnbull; Committee—G. N. Turner, W. Graham, Chas. Forrester, D. Carson, C. Wallen.

The following are the Rules agreed to:—

I. *Name of Society and Qualification of Membership.*
The name of the Society shall be "The Old Scotch Collegians," and all past scholars of the Scotch College who have attained the age of twenty-one years shall be eligible for election as members.

II.—*Committee of Management.*

A Committee of Management, consisting of a President, two Vice-Presidents, Secretary, Treasurer, and five other members, shall be elected annually by ballot at the Annual General Meeting.

III.—*Annual General Meeting.*

The Annual General Meeting of the Society shall be held in the second week in the month of February, notice of which shall be given by the Secretary to each member fourteen clear days before such meeting.

IV.—*Meetings of Committee.*

The Committee of Management shall meet in the last week of each month, five to form a quorum. Absence from two successive Meetings without reasonable cause shall disqualify a member of Committee, and render his position vacant. The Committee shall have power to fill up all vacancies.

V.—*General Meetings.*

A General Meeting of the Society shall be held in the second week in each quarter (that is in the months of February, May, August, and November,) or oftener, at the discretion of the Committee. Notice of such General Meetings shall be sent to each member by circular.

VI.—*Election of Members.*

Any gentleman wishing to join the Society shall forward his name and address, with particulars of his scholarship, to the Secretary, who shall enter his name in a book to be kept for the purpose, and which shall be open for inspection by the members of the Society; and after fourteen days the name of such Candidate shall be submitted to the Committee for election.

VII.—*Annual Subscription.*

The Annual Subscription shall be Ten Shillings, which shall be due and payable after receipt of notice that the same is due. In the event of any member neglecting to pay such subscription within two months after receiving such notice, he shall cease to be a member, but may be re-admitted on satisfactory explanation, and on payment of all back subscriptions.

VIII.—*Alteration of Rules.*

None of the Rules shall be altered, nor any new Rule introduced, except at a General Meeting of the Society, to be specially called for the purpose, and of which three weeks' notice shall be previously given by circular to each member.

IX.—*Special General Meetings.*

By order of the Committee, or upon the written

requisition of ten members of the Society, the Secretary shall call a Special General Meeting, giving at least fourteen days' notice by circular to each member of its object or objects.

X.—*Quorum; Proxies.*

At all General Meetings of the Society, whether Special or not, twenty members shall form a quorum, and proxies shall be allowed, but shall not count in the formation of a quorum.

XI.—*Bye-Laws.*

The Committee shall have power to make Bye-Laws in accordance with the Rules.

XII.—*Expulsion of Members.*

A General Meeting, specially called for the purpose, shall have power to expel any member for any alleged gross misconduct, but such member shall have at least one week's notice that such allegation is about to be brought before the Society; and he shall have the opportunity of personally explaining his conduct before the said meeting; but should he neglect to appear the members of such meeting shall proceed to adjudicate in his case. The opinion of such General Meeting shall be obtained by ballot, when, if two-thirds of the members voting at the meeting shall decide that the accused member has deserved expulsion, he shall cease to be a member of the Society.

The Hon. Robert Ramsay occupied the chair at both meetings, at the first of which sixty-nine "old boys" turned up. A most cordial feeling has been exhibited throughout, and it is expected that the formation of the society will have the effect of binding together, in manhood, those who were boys together. It is intended to make the social meetings instructive and entertaining, and such as it will be a pleasure for "old boys" to attend. The meeting in November will take the form of the annual dinner, and will be held during the race week, to enable the "old boys" in the country to attend, as a large number of them are then in Melbourne.

The committee have held a first meeting, and they have determined to send a circular to every "old boy" whose address can be ascertained, along with a copy of the rules, and after a time a list, to be called the Original Members' List, will be printed and distributed.

The following is the circular referred to:—

The Society of "The Old Scotch Collegians," Melbourne, 23rd September, 1879. Dear Sir,—I have the pleasure to inform you that at a largely attended general meeting of the "old boys," held at Melbourne on the 9th inst., it was unanimously resolved to form a society to be called "The Old Scotch Collegians," and that at a subsequent general meeting held on the 16th inst., rules were adopted as per copy which you will receive herewith. The objects of the society, briefly, are to promote cordiality amongst the old scholars, and foster their interests. It is intended

for the present to hold social gatherings of its members in the months of February, May, August, and November, but it is hoped as the society develops that more frequent meetings will be held, and other objects undertaken. The gathering in November of each year will take the form of an Annual Dinner, and it is intended to hold it during the race week, in order that "old boys" who live in the country and are then visiting the city may have an opportunity of attending. At the meeting on the 16th inst. a Committee of Management was appointed, consisting of President: Hon. Robert Ramsay, M.L.A.; Vice-Presidents: Messrs. A. E. Clarke and D. Wilkie; Hon. Secretary: Mr. Wm. Knox; Hon. Treasurer: Mr. J. F. Turnbull; Committee: Messrs. G. N. Turner, Wm. Graham, Chas. Forrester, D. Carson, and C. Wallen. I have, therefore, on behalf of the Committee of Management, to invite you to forward your name and address in accordance with Rule VI., and it will oblige if you reply hereto as early as possible, as it is proposed to print "The Original Members' List" for distribution at the First Annual Dinner in November next. The Committee will esteem it a favour if you will be good enough to exhibit this letter and the copy of the rules to any "old boys" of your acquaintance, as a number of their addresses, I regret, cannot be accurately ascertained. I am specially directed to call your attention to Rules Nos. VI. and VII., and to ask your cordial co-operation in the movement.—I am, dear sir, yours faithfully, WM. KNOX, Hon. Secretary.

School List.

WE publish in this issue the names of all boys who entered the College during the twenty years extending from 1857 to 1876 inclusive. Those enrolled under 1857 did not necessarily enter school that year for the first time. They were, however, present during the latter part of 1857 after the arrival of the present Principal. Very unfortunately not a single record of any kind referring to the period anterior to 1857 now exists. The College was founded in 1851, and during the six succeeding years was largely attended. It would yet be possible, partially at least, to repair the loss of the rolls by the assistance of those who left the College before August, 1857.
